## Case History

- Worcester Superior Court, Criminal Trial Session *Pending, 2026*
  - Topics for analysis: perception-response time (PRT), speed from video, nighttime visibility, pedestrian conspicuity, photogrammetry, slide-to-stop distance.
  - Expected to testify for the defense at trial.



- Haverhill District Court, Criminal Motion Session *Pending, 2026*
  - Topics for analysis: Airbag deployment, statistical analysis of non-deployment events.
  - Report submitted to attorney. Unknown current case disposition.
- Holyoke District Court, Criminal Motion Session *Oct 2025*
  - Topics for analysis: ergonomics, expected damage from a crash, dynamics of a blunt object strike.
  - Did not testify. Case dismissed by Commonwealth.
- Maine Superior Court, Civil Deposition *Sept 2025*
  - Topics for analysis: motorcycle lateral friction demand based on lean angle, critical speed in a curve based on the radius, friction demand based on turning and/or breaking
  - Deposed in July and September. Unknown if required to testify at civil trial.
- Greenfield District Court, Criminal Motion Session *June 2025*
  - Topics for analysis: speed from video, perception-response, slide-to-stop, swerve to avoid.
  - Lead charge dropped by Commonwealth upon receipt of report.
- Massachusetts Registry of Motor Vehicles, Surcharge Hearing *Jan 2025*
  - Topics for analysis: roadway design, nighttime visibility, lane markings, crash orientation.
  - Testified before Appeals Board. Petitioner found responsible for surcharge.
- Worcester Superior Court, Criminal Trial Session *Jan 2025*
  - Topics for analysis: EDR data, coefficient of friction from spin, exceptions to EDR data reporting accurately.
  - Have not testified. Case still pending, however, likely to be a plea bargain.
- Greenfield District Court, Criminal Motion Session *Nov 2024*
  - Topics for analysis: minimum speed to hydroplane, roadway design.
  - Did not testify. Dismissed upon completion of pre-trial probation.
- Greenfield District Court, Criminal Motion Session *Feb 2024*
  - Topics for analysis: Roadway design standards: proper lane width, speed from video, civil motor vehicle infractions.
  - Testified at Motion to Suppress hearing. Qualified as an expert witness by Judge Mazanec III.



- Lowell District Court, Criminal Trial Session *Nov 2022*
  - Topics for analysis: efficacy of SFSTs on alleged drug use.
  - Did not testify. Set for jury trial and later dismissed all charges.

  - Topics for analysis: hot shock, pole impacts, EDR capability.
  - Did not testify. Unknown disposition.
